Benefits of Using Amazon for Business

Purchases are exempt from Sales Tax.

User Responsibilities

- Must be a P-Card holder in good standing.
- Must be invited by your DCM to join the UAG.
- The University's P-Card is the only method of payment

User Responsibilities

 All purchases on the P-Card must be in compliance with University procurement policies and procedures.
