

More than 80% of the services performed by Procurement Services are driven by regulatory requirements, largely state and federal laws.






Relationship between Statutes, Rules and Policies

Recent Rule Changes

- Professional and Artistic (P&A) Small Purchases
 - Publishing to Bulletin
 - SPO Review
- Competition for Small Purchases
 - Multiple Quotes
- Stringing/Recurring Need
 - Cannot Artificially Divide a Procurement

Recent Rule Changes

- Change Orders
 - Required for changes > \$10,000 or time completion of > 30 days
 - Must be a Written Agreement
- Procurement File Documentation
 - Publically Available within 7 Days of Award
- Sole Source Justifications
 - Sample Products, Pilot Projects Not Applicable Justification
- Conflict Review Process
 - SPO Now Reviews

 - Conference Registrations
 - P-Card Prohibition for Tuition and Fees
 - Clarified Tax Exemption Restrictions
- Human Subject Payments
- IT Accessibility
 - P-Card Software Purchase and Electronic Services Form
